### **Overview:**

The Senior Geologist is responsible for direction of field investigations of legacy projects as well as future potential project impacts on soil and groundwater. He or she is responsible for client contact, study design, supervision of work plan preparation and execution of field projects that include environmental sampling of different media. The Senior Geologist analyzes and interprets data, directs midlevel and support staff in report preparation while providing senior leadership and mentoring interfaces with clients, and assists with business development within the sector.

### **Responsibilities:**

- Direct site investigation field activities, including but not limited to environmental site assessments; hazardous waste site investigations; field sampling (soil, groundwater, surface water and air); Phase I/II environmental site assessments; evaluation of remedial action alternatives for contaminated soil and groundwater and remedial oversight.
- Conduct data analyses and interpretation of field and analytical data.
